



12[™] GENERAL ASSEMBLY

he 12th Assembly of the Network, held in Santa Cruz de Tenerife on the 8th of November, attended by over seventy political representatives and municipal technicians, was accompanied by the Workshops for the implementation of Pilot Projects held on the 9th of November.

Prior to this, there was a guided visit to the Palmetum organised by the Santa Cruz de Tenerife City Council, where attendees could observe the successful action carried out on the former landfill, decommissioned in 1983 and today, after twenty years of work, converted into a botanical garden of high ecological value, home to one of the most important collections in the world and among the best botanical gardens specialised in palm trees.

The Assembly was presided over by Mr Juan Espadas, Mayor of Seville and President of the Network, accompanied by two representatives from the Santa Cruz de Tenerife City Council, Ms Zaida González, First Deputy Mayor, and Carlos Correa, Councillor for Accessibility, as well as Mr Carlos Daniel Casares, Secretary General of the FEMP.

After forming the Assembly, approving the minutes of the previous Assembly and presenting the 2017 activity report, attendees were informed of the implementation status of the 2018 work plan.

During 2018, the Project for Calculation and Registration of Municipal Carbon Footprints was created, which had a training session for Local Governments interested in calculating their footprint.

The Climate Change School Campaign was enriched with the design of new teaching materials for schools, with the incorporation of information on the Stars Project and an educational video on the origin and consequences of climate change.

Information was also provided on the status of the Pilot Projects approved in the 2017 Logroño Assembly, which would be worked on in the Workshops planned for the following day.

The Assembly ended with the participation of many attendees who shared their opinions and proposals for action for 2019.

7TH EDITION OF THE GOOD LOCAL PRACTICES FOR THE CLIMATE AWARD n 2018 the Spanish Network of Cities for the Climate convened the 7th edition of the Good Local Practices for the Climate Award, aimed at City Councils, Provincial Delegations, Town Halls and Insular Councils belonging to the Spanish Network of Cities for the Climate, with the objective of compiling and disseminating the actions carried out by Spanish Local Entities in the field of climate change mitigation and adaptation after 2012.

The Award was conceived with the objective of collecting the results of the initiatives carried out by members of the Network for the prevention of climate change, allowing the establishment of evaluation criteria which help to promote measures for action against its effects and disseminate innovative experiences carried out by Local Entities.

In this edition, the Local Entities of the Network were able to present the actions carried out in their Local Entity encompassed in the following categories:

- Mobility
- Circular Economy
- Energy Efficiency, Urban Development and Construction
- Citizen awareness
- Adaptation to climate change
- Development of citizen participatio

7TH EDITION OF THE GOOD LOCAL PRACTICES FOR THE CLIMATE AWARD

The categories of Adaptation to climate change and Development of citizen participation were incorporated for the first time into the Good Practices for the Climate Award.

- Energy Efficiency, Urban Development and Construction: Bigastro, Granollers, Madrid, Real Sitio de San Ildefonso, Riba-roja de Túria, Tomelloso, Viladecans, Xirivella and Yunguera.
- Citizen awareness: Granollers, León and Riba-roja de Túria.
- Adaptation to climate change: Granollers, León, Mairena del Alcor, Council of Badajoz and Commonwealth of Sustainable Municipalities of Cantabria.
- Development of citizen participation: Albacete, Bigastro, Oviedo and Puente Genil.



WORK GROUPS

3.1 AGREEMENTS AND ACTIONS

Through the Work Groups, the meeting of the Government Council held on the 20th of February 2018 in Gavà established the way of addressing and defining the scope, planned budget and time necessary for the pilot projects approved at the 11th Assembly, held on the 3rd of November 2017 in Logroño.



Mitigation Policies Work Group:



Circular Economy Work Subgroup:

- Implementation of a project of individual composting and separate collection of biowaste
- Support for green public procurement in Local Entities



Mobility Work Subgroup:

- Collection, analysis and dissemination of the best practices in the field of mobility at a municipal level
- Creation of work mobility plans and implementation of electric mobility



Renovation and Energy Efficiency Work Subgroup:

- Creation of an energy renovation platform, at the proposal of the Financing Work Group
- Development of heating and cooling networks in municipal buildings
- Support for municipal management to improve the efficiency of the lighting system through replacement with LED and intelligent control



Climate Change Adaptation Work Group:

- Report on the best practices in the field of adaptation to climate change at a municipal level
- Expansion of content on combatting Climate Change at school
- Coordination of Workshops for Calculation and Registration of Carbon Footprint for SMEs

Of the 10 pilot projects approved by the Assembly of the Network, there were two types of project:

- a) Dissemination, awareness and information projects.
- b) Pilot projects to be undertaken in Local Entities of the Network.

With regard to the first type of project, work began on projects which did not require an assigned budget, such as "Work mobility plans and implementation of electric mobility". For their implementation and development of the project, a circular was sent to all members of the Network asking for their actions carried out in the field of work mobility and electric mobility.

Additionally, to initiate the development of the "Support for green public procurement of Local Entities" and "Implementation of individual composting and separate collection of biowaste", members of the Network were asked to send approved procurement documents including sustainability criteria for contracting services and/or acquisition of goods, as well as experiences of projects carried out for composting and separate collection of organic matter.

With regard to the second type of pilot projects, the Work Groups of the Network

defined the projects for their subsequent implementation in the Local Entities of the Network

3.2. PILOT PROJECTS

The development of pilot projects during 2018 was as follows:

COMPOSTING AND ORGANIC MATTER

Coordination of this work involved the experience of the Council of O Grove, which has coordinated the actions of the Circular Economy Subgroup and also has experience of individual composting and community composting in its municipality.

The Circular Economy Subgroup tried to identify success stories which were replicable for the implementation of individual composting and separate collection of biowaste.

After gathering the experiences and contributions of the attendees, the incorporation of the community composting in the pilot project was proposed, as it usually complements the individual composting experiences in areas with different types of homes.

All members of this Subgroup agreed on undertaking monitoring to maintain the separation of organic matter, as well as the need to transpose European directives to allow the establishment of monitoring systems and sanctions in the case of non-compliance.

In view of the experiences described, the development of three types of projects was proposed:

- a. Implementation of individual composting of organic matter.
- b. Implementation of community composting of organic matter.
- c. Separate collection of organic matter.

Recommendations for action were established for the implementation for each of the types of project, in all cases requiring the population's awareness and information.

At all Workshops for the implementation of the pilot projects, held on the 9th of November, the recommendations for action were presented for the implementation of the individual composting, community composting and organic waste bin projects.

SUPPORT FOR GREEN PUBLIC PROCUREMENT IN LOCAL ENTITIES

The objective of this project was to create a consolidated document template from the documents received, which would serve as a standard document, or if this were not possible, to select models which could serve as good practice, to disseminate among the city councils.

The Circular Economy Subgroup, responsible for developing this project, agreed to create a catalogue of tools and recommendations with the objective of:

- Providing members of the Network with instructions on how to include green criteria, created by the Council of Cádiz: it recommended incorporating, in the subject of the tender for the item required, that it be "sustainable" or "green", to avoid offers due to limiting participation.
- 2. Selecting criteria for the documentation of technical clauses and awarding. Three general categories are established for the organisation of the documents:
 - a. Supply
 - b. Works
 - c. Services
- 3. Providing members of the Network with links where information and experiences of great use can be obtained, such as:
 - a. MITECO: Ecological contracting plan
 - b. IDAE: For public lighting and energy service companies.
 - c. IHOBE: Contracting documents organised by topic.
- 4. Adapting the Spanish Network of Cities for the Climate website for the incorporation of all these documents in the Network Work Groups section.

COLLECTION, ANALYSIS AND
DISSEMINATION OF THE BEST PRACTICES
IN THE FIELD OF MOBILITY AT A
MUNICIPAL LEVEL

This project sought to introduce members of the Network to good municipal practices in the field of mobility, disseminating them through the Network website.



CREATION OF WORK MOBILITY PLANS AND IMPLEMENTATION OF ELECTRIC **MOBILITY**

For the development of this project, the work carried out by the Network and the Transport and Infrastructure Commission of the FEMP were coordinated in the fields of work mobility and electric mobility.

ENERGY RENOVATION PLATFORM

The creation of a Platform was proposed, including both the renovation of buildings for the improvement of energy efficiency and the development of heat and cold networks in municipal buildings.

Through the Addendum on actions for 2018-2019 to the collaboration Agreement between the FEMP and the Fundación la Casa que Ahorra foundation for the improvement of energy efficiency, an operating proposal for the Platform was created, with the objective of allowing the renovation of degraded

areas or neighbourhoods, simplifying management and allowing collaboration between public and private entities.

SUPPORT FOR MUNICIPAL MANAGEMENT FOR THE IMPROVEMENT OF THE EFFICIENCY OF THE LIGHTING SYSTEM THROUGH REPLACEMENT WITH LED AND INTELLIGENT CONTROL

Throughout the year, Network the collaborated with the IDAE to continue supporting the Local Entities that wished to improve the efficiency of the lighting system.

REPORT ON BEST PRACTICES IN THE FIELD OF ADAPTATION TO CLIMATE CHANGE AT A MUNICIPAL LEVEL

To allow better knowledge of the policies developed in the field of adaptation to Climate Change at a municipal level, a new category of the Good Practices for the Climate Award was created.

EXPANSION OF CONTENT ON COMBATTING CLIMATE CHANGE AT SCHOOL

By agreement with the OECC, the climate change school campaign was enriched with information on the Stars Project and an educational video on the origin and consequences of climate change.

WORKSHOPS FOR **CALCULATION** REGISTRATION OF CARBON AND **FOOTPRINT**

These workshops continued to be developed through the project for Calculation and Registration of Municipal Footprints carried out annually by the Network.



INFORMATION AND AWARENESS CAMPAIGNS

his section complies the most notable actions carried out for the purpose of informing and raising awareness of climate change: workshops, the expansion of the educational campaign on climate change, incorporating school mobility and the creation of informative and educational documentation.

WORKSHOPS FOR THE IMPLEMENTATION OF PILOT PROJECTS. 9TH OF NOVEMBER. SANTA CRUZ DE TENERIFE.

At these Workshops, the agreements and work carried out by the members of the Work Groups were presented:

- <u>Development of Pilot Project</u>. The

- <u>Greenpublicprocurement</u>. The coordinator of this project, Pablo Quero, of the Council of Cádiz, presented the tools available and the recommendations for action agreed

by the work group. Municipal experiences were also presented, such as that of Miajadas City Council for the incorporation of green procurement criteria for children's equipment in parks in the context of the new Contract Law of the Public Sector.

Implementation of composting and separate collection. The coordinator of the Circular Economy Subgroup, Francisco Meis, of O Grove City Council, presented project models for the implementation of individual composting, community composting, and separate collection of organic matter.

The experiences of the Services of the Pamplona Region and the Rivas-Vaciamadrid City Council were presented.

<u>Sustainable mobility</u>. The coordinator of the mobility subgroup, Jorge Romea, of Rivas-Vaciamadrid City Council, reported on the work carried out to compile information from members of the Network on work mobility plans and implementation of electric mobility. For the catalogue of good mobility practices, it was noted to incorporate actions presented in this year's edition of the Good Local Practices for the Climate Award.

In the presentation of experiences, the actions being carried out in the municipality by the Santa Cruz de Tenerife City Council in sustainable movement and smartcities were presented.

Additionally, representatives of the DGT presented the objectives of the Stars Project for sustainable school mobility and their work methodology, and presented the implementation of the Stars Project in the municipality of San Cristóbal de la Laguna.

SCHOOL PROGRAMMES ON MOBILITY AND CLIMATE CHANGE

Since 2015, the Network has carried out the School Educational Campaign on Climate Change, with the objective of providing municipalities tools for raising the awareness of their population, specifically that of Primary Education students, explaining to them in a simple and visual way what they and their families can do so as not to contribute to climate change.

Due to the demand of Local Entities belonging to the Network, in 2016 and 2017, the Campaign expanded its content, both of physical and digital materials.

In 2018, new games aimed at the first years of primary education were incorporated into the Campaign, such as sustainable dominoes, and for the final years, the game "What is happening to the Climate and the Planet?", among others.

To support the teachers who use the resources of this Campaign, a short guide

was created in which, after a simple theoretical introduction on climate change, explained how to use each of the materials available and the recommended course for their use. Additionally, some activities were offered for carrying out with students.

DOCUMENTATION FOR INFORMATION AND AWARENESS

CREATION OF A VIDEO ON CLIMATE CHANGE, ITS EFFECTS AND ACTIONS FOR MITIGATION

An educational video aimed at children, "Klimatea and climate change", was created, focused on explaining what climate change is, its effects and actions for mitigation, using simple language, in which the narrator is a robot sent from the future. The video is available on the Network website www. redciudadesclima.es in Spanish and English.

PUBLICATION COMPILING THE ACTIONS OF THE NETWORK

This is a publication which reviews the activities undertaken by the Spanish Network of Cities for the Climate.

Since the establishment of the Network, the Local Governments which belong



to it have been supported so that they can achieve their objectives for reducing emissions and adapt to the effects of Climate Change.



To do so, projects and technical documents have been created on the implementation of measures for energy, mobility, construction and urban planning, as well as reference manuals and their monitoring. Workshops, conferences, courses and seminars have been organised to facilitate City Councils in access to all progress being made in the understanding of the causes and effects of climate change, as well as the advances made on mitigation and adaptation actions. The actions of Local Governments have been disseminated and promoted, with participation in conferences and awards for the best local actions for the climate.

Due to all of this, the Network has established itself as the main actor on climate change policies with other networks and agents working in this field at a national and European level.



PROJECT FOR **CALCULATION AND** REGISTRATION OF MUNICIPAL CARBON **FOOTPRINTS**

he Spanish Network of Cities for the Climate promotes the calculation and registration of Carbon Footprints in its Local Entities with the objective of contributing to the reduction of greenhouse gas emissions. Therefore, since 2014, it has supported Local Entities of the Network in the calculation of the carbon footprint of the installations and facilities that belong to them. Firstly, the results are compiled in Reports which are prepared annually; secondly, municipal technicians are trained so that in following years they are able to calculate and register the footprint of their corporation autonomously.

Specifically, for the preparation of the 2018 project, participation was requested of members of the Network that were interested in registration in the Carbon Footprint, Offset and Carbon Dioxide Absorption Register of the Ministry for Ecological Transition (MITECO).

A report was created evaluating the situation of 9 Local Entities participating in the calculation of their carbon footprint and the design of CO2 emission reduction plans. For this purpose, they had a work tool provided by MITECO that greatly facilitated the calculation of the footprint and the presentation of the results.

The year selected for the calculation of the carbon footprint was 2017, and in some cases,

2016, depending on the data provided by each Local Government. The project also allowed the recognition of the Ministry, through the registration of the footprints calculated.

FOOTPRINT CALCULATION TRAINING MODULE

On the 5th of November the OECC carried out an online presentation on the carbon footprint, offset and carbon dioxide absorption register, in which technicians from the Network participated.

On the 21st of November in Madrid, a Carbon Footprint training module was held, lasting one morning. The training began with a presentation by the OECC on the carbon footprint and absorption project register. Then, the Director of the Energy Agency of Valladolid explained her experience in the calculation and registration of the footprint of her city for several years. The course ended with the entry of data from a case study in a tool designed by the OECC for the calculation of the footprint.

Finally, during 2018, at the proposal of the OECC, the Technical Cooperation Programme in Costa Rica was participated in, "COOTEC-Costa Rica: Strengthening Costa Rican institutions through the generation of knowledge and skills, spaces for coordination and exchange of experiences". In this context, three technical representatives of the Network, from the Council of Cádiz, Gavà City Council and Málaga City Council went to Costa Rica to present their experiences

at a workshop held on the 24th and 25th of September, on the development of instruments for the implementation of decarbonisation policies. Additionally, during the first week of October, a delegation of representatives from Costa Rica was received at the FEMP and in several Spanish cities (Madrid, Málaga, Seville and Gavà), where they could discover first hand some of the actions implemented in different fields for the reduction of greenhouse gas emissions.



or the most extensive possible dissemination of the actions presented at the 7th Good Local Practices for the Climate Award, after finding the winners, they were compiles on an interactive CD for distribution among the members of the Network. Additionally, the content of the CD has been incorporated on the website of the Spanish Network of Cities for the Climate.

he Spanish Network of Cities for Climate is formed by 315 Local Governments representing 29.197.417 inhabitants, more than 60% of Spanish population.


Amongst the 312 members, 298 are City and Town Councils, 13 are Provincial Governments and Insular Councils, and one is an Association of Municipalities.

Local Governments by population segment


